



Big Sugar Golf Club Annual Membership Application

Please check the membership for which you are applying:

- () **Annual Single Membership = \$225/month, or () \$2,475/year (w/ 1 month free)**
- () **Annual Family Membership = \$275/month, or () \$3,025/year (w/ 1 month free)**
- () **Annual Weekday Membership = \$175/month, or () \$1,925/year (w/ 1 month free)**

An initiation fee of \$300 is required if your Single, Family, or Senior membership is paid on a monthly basis, rather than annually.

Membership: Big Sugar Golf Club is a semi-private club operated by Big Snowballs LLC. I hereby acknowledge that my membership in the Club is not an investment in the Club, nor does it provide an equity or ownership interest in the Club or the facilities operated by the Club which are operated solely by Big Snowballs LLC. Membership in the Club does not confer upon me a vested or prescriptive right or easement to use the facilities operated by the Club. I acknowledge that a member acquires only a revocable license to use the facilities operated by the Club. Big Snowballs LLC reserves the right, in its sole and absolute discretion, to terminate memberships in the Club, to discontinue the operation of any or all of the facilities operated by the Club, to sell or otherwise dispose of the facilities operated by the Club in any manner whatsoever and to any person whomsoever and make any other changes in the terms and conditions of membership, or the facilities available use by members. The use of the facilities operated by the Club may be restricted or reserved from time to time as determined by the Club or Big Snowballs LLC. Cart fees may be applied for more than one (1) round of golf per day (\$10 per additional round).

Rules, Regulations, Fees and Etiquette: The Club reserves the right, in its sole discretion, to modify the Terms and Conditions of membership, including, without limitation, the right to restrict or reserve the use of Club facilities.

Hold Harmless: I hereby acknowledge that the use of the facilities operated by the Club or Big Snowballs LLC and any privilege or service incident to membership in the Club is voluntary and that any use or acceptance of any service or privilege incident to membership is undertaken with the knowledge of the risk of possible injury. I hereby accept any and all risk or injury to myself, my guests, and family sustained while using the facilities operated by the Club or Big Snowballs LLC, or involved in any event or activity incident to membership in the Club. In accepting the risk of injury, I understand that I am relieving the Club, Big Snowballs LLC and those affiliated with either of them from any and all loss, claims, injury, damage, or liability sustained or incurred by me, my guests and family resulting from or arising out of any conduct or event connected with membership in the Club and use of any of the facilities operated by the Club or Big Snowballs LLC.

Payment of Account: Club accounts are due and payable upon the first day of each month. Membership privileges will be suspended if not paid by the first day of the following month. All costs and expenses incurred by the Club in the collection of any accounts not paid when due, including but limited to court costs and attorney's fees, whether at the trial or appellate level, shall be my obligation and shall be due and payable upon demand. I further acknowledge and agree to be jointly and severally responsible for all charges and expenses as may be incurred by authorized family members and guests. Accounts past due for 10 days will be subject to a 10% late fee.

This Agreement and Application may from time to time be amended by the Club.

Annual Membership for all Accounts: Membership will be reviewed on an anniversary basis. Member must agree to make payments on their account for one full year from the date of the contract. If member does not wish to stay with Big Sugar Golf Club, they must give thirty (30) days notice prior to their anniversary date.
